
On August 22, 2013, at 9:30 a.m., or as soon thereafter as practicable, the City Council for the City of Tampa, Florida, shall conduct a public hearing in the City Council Chambers, Third Floor, City Hall, 315 East Kennedy Boulevard, Tampa, Florida, to consider the adoption of a non-ad valorem assessment roll for a 2013 (fiscal year 2014) non-ad valorem assessment within the downtown area of the City of Tampa, the boundaries of which are identified on the map included in this notice. The purpose of the assessment is to pay for a portion of the operating costs of the Tampa-Ybor Historic Electric Streetcar Project.

The proposed 2013 Special Assessment of \$0.33 per \$1,000 of assessed value, as evidenced on the certified preliminary roll provided by the Hillsborough County Property Appraiser on June 27, 2013, will be collected by the tax collector as part of real property owners' ad-valorem tax bills. All affected property owners have the right to appear at the public hearing and the right to file written objections with the City Council within twenty (20) days of this published notice.

If any person decides to appeal any decision of the City Council with respect to any matter considered at the public hearing, he or she will need a record of the proceedings; and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

In accordance with the Americans with Disabilities Act and Section 286.26, Florida Statutes (2003), persons with disabilities needing special accommodation to participate in this hearing should contact the City Clerk's Office at least forty-eight (48) hours prior to the date of the public hearing.
