The SCHOOL BOARD OF HILLSBOROUGH COUNTY, Florida, seeks sealed bids from qualified bidders for three roof replacement projects and a modular clinic. Roofing project scopes provide for replacement of roofs at selected sites in Hillsborough County, Florida with estimated project costs between \$550,000 and \$1,300,000. Separately, the Board is soliciting for the procurement, permitting, installation and build-out of a new modular building and associated sitework, with an estimated construction cost between \$250,000 and \$490,000 to provide a clinic at Hunters Green Elementary school. Separate bid documents will be issued for each project, and separate bid responses are required.
