
PUBLIC HEARING NOTICE

Pursuant to the Florida Brownfields Redevelopment Act, a public hearing is being held at 6:00 p.m. on Tuesday, December 3, 2013 at the Apollo Beach Chamber of Commerce, 315 S. Tamiami Trail, Apollo Beach, Florida regarding the Tampa Port Authority application for Brownfield Area Designation of its Port Redwing property, located on Tampa Bay in southwest Hillsborough County. The Port Redwing property consists of approximately 151 acres located at 5734 Pembroke Road and 5740 Pembroke Road, Gibsonton, Florida. The purpose of the December 3 hearing is to take public comment on the size of the Brownfield Area, the objectives for rehabilitation, job opportunities and economic development anticipated, neighborhood residents' considerations, and other relevant local concerns. The Brownfield Area Designation will allow an agreement between the Tampa Port Authority and the Hillsborough County Environmental Protection Commission to undertake environmental remediation of the property.

The Hillsborough Area Regional Transit Authority (HART) will implement bus service changes effective Sunday, November 17, 2013.

CHANGES OR ADJUSTMENTS ARE BEING MADE TO THE FOLLOWING ROUTES

- New Late Night Service: Routes 2, 6 and 30 will run until midnight on Saturday and Sunday.
- New Weekend Service: Route 14 and 57 will operate on Saturday. Route 37 will operate on Sunday.
